

Detailed Explanations of the Rules Governing the Requirements
for Faculty Members of Wenzao Ursuline University of Languages to Undertake
Industry-related Study or Research for Six Months Every Six Years

Discussed and approved by the Directors' Meeting on May 17, 2016

<p>I Effective Date</p> <p>(I) The “Implementation Regulations Governing Teachers in Technical and Vocational Colleges and Universities Undertaking Industry-related Study or Research” was announced on November 18, 2015. Hence, the six years referred to herein began on November 20, 2015. All full-time teachers teaching in technical and vocational colleges and universities who teach professional courses or technical courses are required to complete their industry-related study or research that lasts over six months before November 20, 2021. In other words, any collaboration between the teachers and the corporate sector or industry completed before (including) November 19, 2015 will not be counted. The six-month industry-related study or research must be completed between November 20, 2015 and November 20, 2021.</p> <p>(II) New teachers are required to fulfill the same requirement to complete their industry-related study or research that lasts over six months within six years after their employment contract becomes effective.</p>	<p>The effective date of the “Implementation Regulations Governing Teachers in Technical and Vocational Colleges and Universities Undertaking Industry-related Study or Research”.</p>												
<p>II Teachers who are required to fulfill the requirement</p> <p>(I) The criteria formulated by the University are as follows:</p> <p>1. Courses offered in various departments by teachers who belong to various teaching centers (with no students of their own) are also considered professional or technical courses.</p> <p>(III) Simply put, with the exception of teachers who belong to General Education Center, Center for Ursuline Education and Center for English Language Teaching, all teachers are required to fulfill the requirement. If teachers from the three centers offer courses in other departments, graduate school or module, regardless of the number of courses offered, they shall also fulfill the requirement. <p>III Definition of Industry-related Study or Research</p> <p>(I) Teachers provide service or conduct research at the location of the collaborating institution or company. (The University proposes that teachers can apply to provide in-depth service that lasts six months in a collaborating institution or company.)</p> <p>(II) Teachers collaborate with collaborating institution or company through academia-industry collaboration projects, and the projects will result in technology transfer, commercialization of a prototype or other achievements that contribute to development of the industry. (The University proposed that teachers can sign an academia-industry collaboration project or academia-industry collaboration and research project</p>		The definition of industry-related study or research of the “Implementation Regulations Governing Teachers in Technical and Vocational Colleges and Universities Undertaking Industry-related Study or Research”.

<p>with another institution or company.)</p> <p>(III) Teachers participate in in-depth study co-organized by the University and collaborating institution or company. (The University proposes that teachers can engage in in-depth study during the summer/winter vacation or other holidays.)</p>	
<p>IV The duration</p> <p>(I) When teachers choose to engage in in-depth practical study or research, the duration will be calculated according to the actual time spent on the study or research. In principle, the calculation unit will be “half a day”. Five days will be counted as one week and four weeks will be counted as one month.</p> <p>(II) As all in-depth service is required to last for over six months, once a teacher has completed an in-depth study, he/she has completed the requirement.</p> <p>(III) If a teacher chooses to sign an academia-industry collaboration project, the duration of the project as stated on the agreement will be counted.</p> <p>If a teacher chooses to engage in all three types of study or research, the duration will be added up (including all types of study or research.)</p>	<p>The duration of industry-related study or research of the “Implementation Regulations Governing Teachers in Technical and Vocational Colleges and Universities Undertaking Industry-related Study or Research”.</p>
<p>V Requirement of study or research</p> <p>(I) Whether a teacher chooses to engage in the abovementioned industry-related study or research, the project has to be related to the teacher’s professional expertise.</p> <p>(II) The industry-related study shall be related to actual operation of the market. Site visits or classes are excluded.</p> <p>(III) The project should produce an actual result or outcome, such as research on new technology or technology transfer, product development, actual participation of company operation or management, and specific evidence should be provided. <p>committee.</p> <p>(IV) If a teacher chooses to participate in academia-industry collaboration project, the total amount of the project shall be 50,000 NTD or over. <p>VI Collaborating institutions</p> <p>(I) In principle, the collaborating institution shall be a public or private institution, excluding educational institutions and cram schools.</p> <p>(II) Teachers teaching language courses in the eight departments and centers, including: English Department, French Department, German Department, Spanish Department, Japanese Department, Department of Foreign Language Instruction, Department of Applied Chinese and Center for Teacher Education will be considered exceptions. <p>be on the list provided to the Ministry of Education for the first phase of “Practical Curriculum Development Project”. (For instance, if the department has already signed an MOU with the collaborating institution, the department (center) can claim that teachers collaborating with the institution meet the original goals of the department (center) to serve the industry.</p> <p>2. Departments which have not completed the first phase of the “Practical Curriculum Development Project” should use this academic year and the following academic year to sign an MOU with collaborating institutions. Teachers of the department can then choose from the list of collaborating institutions to engage in in-depth research or study.</p> <p>3. For institutions that are not listed in the first phase of “Practical Curriculum Development Project”, it is suggested that the department’s overall development should be considered and a list of specific potential collaborating institutions shall be provided to be reviewed and confirmed by the Promotion Committee for Faculty Engaging in Industry-related Study and Research to be established in the near future.</p>

	Question	Answer
1	Question raised on 105/05/23: If a teacher chooses to sign an academia-industry collaboration project, the duration of the project as stated on the agreement will be counted. Does the same rule apply for co-principal investigator(s)?	For the same collaboration project, there can only be one principal investigator and a maximum of three co-principal investigators; the same duration of the project will be counted for both the principal investigator and co-principal investigators.
